In response to the bids invitation letter No. Chem/2024/5103 dated 25/01/2024 of this department, for the procurement of item "UV Vis spectrophotometer and data acquisition system" following three firms have submitted their bids within the prescribed time period.

- (i). M/s Metro Trading Corporation, Jaipur
- (ii). M/s Vedant Sales Corporation, Jaipur
- (iii). M/s Hitech Biochemical Corporation, Jaipur
 - 1. (a) After careful examination/evaluation, it has been observed that two firms (M/s Vedant Sales Corporation, Jaipur, M/s Hitech Biochemical corporation, Jaipur) have not provided the required documents related to the criteria for technical evaluation and qualifications for the item no.1 *i.e.* UV Vis spectrophotometer as mentioned in the Chapter-4 of the tender document. Both of the two firms have been disqualified.

(b) The project tenure is almost on completion and closure of current financial year is also reaching soon while principal Investigator (PI) is in urgent need of this equipment for her research work. Timely procurement of this equipment is crucial for the progress of her research. So the committee recommended that the procurement of "UV- Vis spectrophotometer" equipment may be continue with the single firm (eligible firm) *i. e.* M/s Metro Trading Corporation as per RTPP- 2013 rule 63 (4).

(c). The minor deviations in specifications have been considered as per the requirement of the project by the technical committee in accordance to the General Terms and Conditions given in the tender document.

- 2. The objections related to any matter regarding the procurement of item "UV-Vis spectrophotometer" from all the concerned firms may be submitted to the office of the Head of the Department. Objections may also be email to the e-mail addresses: chem.uor@gmail.com or jyoti.jain123@gmail.com on or before 03:00 PM, 26.02.2024. The objections received after the due date and time (*i.e.*, 03:00 PM, 26.02.2024) will not be considered. The Commercial or Financial Bids of the eligible firm will be opened on 26.02.2024 at 03:30 PM in the staff room of the Department of Chemistry.
- 3. None of the three firms have submitted detailed specifications for item no. 2, which is the Data Acquisition System. So, all three firms are ineligible for the procurement of the Data Acquisition System.
