



## MEMORANDUM OF UNDERSTANDING

Between

University of Rajasthan

and

Sumedha

### Introduction

This Memorandum of Understanding (MoU) is made on November 28, 2023 between University of Rajasthan, located at JLN Marg, Jaipur (hereinafter referred to as "UoR"), and SUMEDHA (hereinafter referred to as "Sumedha"), located at 5, Kesha Vihar, Gopalpura Bye Pass, Jaipur. Both parties recognize the importance of collaboration in education, research, social development and community engagement and have agreed to cooperate for mutual benefit.

### Objectives

The purpose of this MoU is to establish a framework of cooperation between University of Rajasthan and SUMEDHA in areas of common interest. The main objectives include:

- Internship and training opportunities for students
- Joint community development programs
- Collaboration on research projects related to social issues
- Knowledge sharing and capacity-building workshops

### Areas of Collaboration

The parties agree to work together in the following areas:

- Community Outreach: Joint initiatives to address social, environmental, or educational challenges.
- Student Engagement: Internship programs, volunteer opportunities, and project work.
- Capacity Building: Organizing workshops, seminars, and training programs.
- Research and Development: Collaborative research projects, data sharing, and joint publications.

### Roles and Responsibilities

UoR will provide faculty, research support and students for mutually decided programmes

Sumedha will contribute field expertise, community contacts, project design and Merit cum need scholarships for students of UoR.

### Funding and Resources

The MoU does not constitute a financial obligation for either party unless explicitly stated in separate agreements. Specific projects will be developed with clear financial arrangements as needed.

### Confidentiality

Both parties agree to respect confidentiality regarding any sensitive information shared during the partnership unless otherwise agreed in writing.

### Duration and Termination

This MoU will remain in effect for a period of 3 years, starting from the date of signature. It may be renewed or amended by mutual consent. Either party can terminate the MoU with one month's written notice to the other party.

### Dispute Resolution

Any disputes arising under this MoU will be resolved amicably through discussions between the parties. If unresolved, both parties may refer the matter to mediation.

### Miscellaneous

This MoU does not create any legal or financial obligations between the parties beyond what is specifically mentioned. Any specific projects or activities will require separate agreements.
