## MEMORANDUM

Sub: Revision of pension of Pre 01.01.2016 University Pensioners/Family Pensioners who retired/died while drawing pay in UGC pay scale- Prescribing of concordance table for revision of pension/family pension.

In response to the State Government memorandum No. F. 12(6)FD/Rules/2017 Pt-I dated 05.11.2019 and the Finance Committee Res. No. 14 dated 05.11.2020 duly approved the Syndicate Res. No. 6-1.23 dated 29.12.2020 the implementation of the above memorandum in the University of Rajasthan w.e.f. 01.12.2020 as stated below:

1. Attention is invited to Finance Department Memorandum of even number dated 12.06.2019, under this order revision of pension/family pension of the University Teachers including Librarians and PTIs who retired/died before 01.01.2016 while drawing pay in UGC pay scales were issued.
2. It has been brought to the notice of the University that revision of pension/family pension is pending for want of concordance tables.
3. The matter has been considered and it has been decided to prescribe the concordance tables for revision of pension/family pension of the University Teachers including Librarians and PTIs who retired/died before 01.01.2016 while drawing pay in UGC pay scales.
4. Accordingly, Concordance tables number 1 to 5 for fixation of notional pay based on the corresponding pay scale and revision of pension/family pension of employees who retired/died in various pay scales during the 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> pay revision w.e.f. 1.01.1986, 01.01.1996 and 01.01.2006 respectively have been prepared and are enclosed herewith.
5. These concordance tables have been prepared to facilitate revision of pension/family pension of pre-2016 pensioners/family pensioners. Due care has been taken to prepare these concordance tables based on the fitment tables for fixation of pay from 4<sup>th</sup> to 5<sup>th</sup>, 5<sup>th</sup> to 6<sup>th</sup> and 6<sup>th</sup> to 7<sup>th</sup>

Pay revision. In case of any inconsistency in the concordance tables vis-a-vis the relevant rules/instructions, the notional pay and pension/family pension of pre-2016 Pensioners may be revised in accordance with the rules/instructions applicable for fixation of pay in the pay scale rules applicable to the University Teachers, Librarians and PTIs from time to time.

6. The benefit of up-gradation of the pay scale of the post subsequent to retirement shall not be available for the purpose of revision of pension of pre-2016 pensioners/family pensioners.
7. The other terms and conditions of revision of pension/family pension of pre-01.01.2016 University Pensioners/family pensioners shall be as contained in FD Memorandum even number dated 12.06.2019.
8. Non-accrual of Arrears – Notwithstanding anything contained in these rules, no arrear of pension/family pension and Dearness Relief thereon, shall accrue to a pensioners/family pensioner, between 01.01.2016 to 31.12.2016 (both days inclusive), for the period upto 31.12.2016. The Finance Committee UOR deferred the matter of arrear for the period from 01.01.2016 to 30.11.2020 till further decision as State Government is giving grant to University only towards salary of regular employees & pension liability of its retired employees is to be met from University own resources/funds.
