**Sub: Strict Compliance of the University Ordinances regarding Ph.D. programme.**

Dear Sir/Madam,

As you are aware that 'UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degrees), Regulations, 2016' were introduced vide Gazette Notification dated July 5<sup>th</sup>, 2016. Accordingly, University rules/ ordinances for M.Phil./Ph.D. degrees were amended by the Academic Council and approved by the Syndicate vide its meeting held on 21.12.2016. Subsequently, Notification No. 15 dated 04.01.2017 was issued by the University and applications from two types of exempted categories i.e. (i) M.Phil. passed candidates through MPAT and (ii) Teacher Candidates were invited for direct admission in various Ph.D. programme in February, 2017 through Uniraj MPAT-2016 (Phase-I) and admissions were made in respective Ph.D. programmes. Further, a notification for admission in different M.Phil./Ph.D. programmes was issued for Uniraj MPAT-2017(Phase-II) on 23.12.2017 and entrance test was conducted on 22.04.2018 under these new rules/regulations. At a later stage, admissions were made through Uniraj MPAT-2018 (Phase- I), thereafter, incorporating the certain amendments in these ordinances, as per UGC (1<sup>st</sup> Amend.), Regulations, 2018, Notification No. 20, dated 27.11.2019 was issued and MPAT-2018 (Phase-II) was conducted under the provisions of aforesaid Notification No. 20. Both the notifications are available on University website under the Hand Book link.

In the aforesaid notifications, at Ord. 124 (9.1 to 9.5), there is a common provision of three members Research Advisory Committee (RAC) for each Ph.D. scholar constituted by the Department Research Committee on recommendation of the Research Supervisor for periodically review and assessment of the research work etc. of the research scholar. Hence, requirement of Extension/Re-registration for the candidates admitted under these new regulations has been deleted.

**You are, therefore, requested to strictly compliance of the aforesaid provisions of RAC as well as other rules/regulations as provided in these Ordinances.**


