**AGREEMENT OF SERVICE FOR UNIVERSITY OF RAJASTHAN
TEACHERS**

An agreement made on the day of 2021
between..... (hereinafter called the Teacher) of the first
party, and the Syndicate of Rajasthan University, Jaipur (hereinafter called the Governing Body) of
the second party.

The Syndicate hereby (or, as from the date of) appoints
the Teacher as a member of the staff of the University upon the terms and conditions
hereinafter set out and mutually agreed between the parties.

1. The teacher shall devote his whole time to the service of the University, and shall not, without the permission of the Syndicate engage directly or indirectly in any trade or business whatsoever or in any private tuition or in any coaching institute or other work which may interfere with the proper discharge of his duties; but this prohibition shall not apply to work under with the permission of the Vice-Chancellor in connection with the examinations of a University, Board, or Public Service Commission.
2. In addition to the direct teaching specified in Ordinance 141, the workload of teachers would include preparation for teaching, admissions, examinations, internal assessment, and supervision of co-curricular activities, administrative duties and research.
3. The Syndicate shall be entitled summarily to take suitable disciplinary action as per Ordinance 357 [C] the engagement of the teacher for misconduct, but save as aforesaid, shall only be entitled to terminate the engagement after giving three months' notice in writing or payment of three months' salary in lieu of notice and for good cause.
4. The Syndicate shall not terminate the engagement of the teacher whether summarily or otherwise without informing him in writing of the grounds on which they propose to take action and giving him a reasonable opportunity of stating his case in writing, and before coming to a final decision shall duly consider the teacher's statement and if he/she so desires give him/her a personal hearing.
5. The teacher may at any time terminate his engagement by giving the Syndicate three months' notice in writing. He/She shall deliver to second party all books, apparatuses records and such other articles belonging to the university in his possession.
6. The teachers agrees to be bound to follow the provisions of University of Rajasthan Acts, Statutes, Ordinances, Regulations and Rules made by the University and decision of the Syndicate from time to time determining his duties and service conditions.
7. The teacher (first party), shall at all times maintain absolute integrity and devotion of duties and shall not take any part in violent activities which disturb the public peace in the campus and shall not involve in any criminal act and any activities which damage the prestige of the University in the society.
8. Teacher will not give any documents of the University without prior permission of the competent authority to the print/electronic media or press or any other department. He shall maintain the secrecy in the examination work.
9. The teacher shall be entitled to leave according to the University Leave Rules as in force from time to time.
