





INSTRUCTIONS FOR THE CANDIDATES APPEARING FOR COUNSELING

1. Course wise Distribution of Seats

Course	Seats	1. Reservation of seats shall be as per the rules of University of Rajasthan and State Government. 2. 5% seats shall be reserved for PH candidates within all categories as per University Rules. *Subject to 20% increase in the seats for session 2023-24 as per university norms.

2. Eligibility Criteria

1	One Year Diploma in Labour Law, Labour Welfare and Personnel Management	Bachelor of Laws Degree Exam or M.A. in Sociology/Economics/ Social Work/ Psychology/ Public Administration with at least 48% marks in aggregate and with a paper relating to Labours laws as part of their exam or M. Com. Exam in EAFM/Business Administration or MBA at least 48% marks in aggregate and with a paper relating to Labours Laws as part of M. Com. or MBA Course shall be eligible.
2	One Year Diploma in Criminology and Criminal Administration	Bachelor of Laws Degree Exam.
3	One Year Diploma in Taxation Laws and Practice	Bachelor of Laws Degree Exam
4	One Year Diploma Environment Law Protection	Bachelor of Laws Degree Exam

3. List of documents required

The Candidate must bring following documents in original and one set of self-attested photocopies of each document on the day of counseling:

- i. Online Application form (Phase-II) & Score Card for URATPG-2023.
- ii. Valid Photo Identity Card (e. g. Aadhar, Voter Id, Pan Card, DL, etc.)
- iii. LL.B./Diploma marks-sheets (qualifying examination based on which admission is sought). **In case of CGPA/grading system, proof of conversion of CGPA into percentage/ formula must be provided.**
- iv. Category/Caste certificate as applicable issued by the competent authority. Please note that following certificates will be valid:
 - a. **OBC/ MBC certificate issued on or after 30-06-2022**
 - b. **EWS category certificate issued on or after 01-04-2023**
- v. Certificate of Person with disabilities/Differently Abled from the competent authority.
- vi. Transfer Certificate & Character Certificate from the institution of last regular course.
- vii. Recent 04 (Four) passport size photographs.
- viii. Migration Certificate (To be submitted in original within 10 days of the date of admission in Department of law, University of Rajasthan, Jaipur during office hours. It is necessary for the purpose of Enrolment).
- ix. An Affidavit regarding no claim of weightage in qualifying examination by those candidates who have applied for weightage.

4. Fee Structure

- After the allotment of seat, the Candidate must deposit fee through Bank Challan in two days of the seat allotment after counseling. The fee structure given below:


5. The Candidate must present himself/herself personally before the Counseling Committee as per the schedule.
6. No person shall be allowed to enter the Counseling Centre apart from the candidate himself/herself and no other person (e. g. parents, relatives, friends etc.) shall be allowed to take part in the counseling process on behalf of the candidate.

7. In case, a candidate is absent in the scheduled counselling, his/her seat will be filled by the next candidate of the concerned category, in order of merit. No Second chance will be given to such candidate in the counselling for Diploma Courses in Department of Law, UoR, Jaipur University Law College, University of Rajasthan, Jaipur either in Unreserved or in other category (OBC, EWS, MBC, SC or ST)

[Explanation: If a candidate is called in Unreserved Category (All Categories are included) and he/she does not participate in the prescribed day and time of the counselling for him/her, he/she shall not be allowed on the day of counselling scheduled of his/her category in any case. However, such candidate may be eligible for counselling of Diploma Course.]

After the allotment of seat in the counseling process, candidate shall submit the fees in through Bank Challan in the Department of Law through University website within two (02) days of Seat Allotment. The candidate must submit the receipt of fee deposit in the department of law within two days of seat allotment for the completion of admission of the candidate.

8. Candidates must note that participation in counseling does not guarantee the admission as more times candidates than the numbers of seats to be filled are being called for the counseling.
