SUMMARY OF HON'BLE HRM SUGGESTIONS IN NORTHERN ZONE NEP CONSULTATIONS AT GURGAON ON 31ST OCTOBER, 2015

- Prepare an educational history for each State, taking into account the needs and current challenges of social groups.
- List out the oldest educational institutions (schools, colleges/ universities) in the State which have a unique contribution/feature.
- 3 > Prepare a Sports map of each State identifying the specific sports of that region where there is excellence and also potential.
- Prepare an Education Plan for all EBBs and EBDs in the State with a long term vision, factoring in special needs of that region, such as, LWE districts.
- For each District, draw up year –wise and age-wise literacy targets for each year and also targets to reduce number of out of school children that can be reviewed yearly
- £ > Each State to send in digitized and non-digitized material that can be included in the e-Pathshala and National E-Library repository of the Govt. of India,
- 7 Prepare a district-wise skill map identifying the local skill requirements and the gaps.
- $\varphi \succ$ Create an aptitude test template for each State
- Submit information and necessary materials for newly launched programmes of GIAN and SWAYAM so that GOI can facilitate the State in meeting the mandated objectives envisaged in these scheme.
- MHRD proposes to launch 1000 courses on national online platform in local languages and States may contribute to this platform
- 11 Check on duplication in scholarships schemes
- States to identify issues related to UGC, ATCTE and NCTE and resolve when they come to MHRD for PAB meetings
- 3 After Zonal Consultations, Hon'ble HRM to undertake institutional visits, for which each State can identify and prepare a State-wise list.
- States to complete the consultation by the 1st week of Nov 2015 and upload by 12th Nov 2015.
- MHPD to consider a scheme for award to teachers in HFIs which can declared the same day as for the School Education teachers.
- 16 UT of Chandigarh to send best practices adopted by it in schools.
- Additional Secretary (SE&L) should sit with states of J&K, Rajasthari. Harvana and develop a model for donations for schools development.
