NOTICE

After completion of counselling, according to applications received from the candidates we are publishing the **Third List** for admission in LL.M. (General) through counselling in the Department of Law, University of Rajasthan, Jaipur. Candidates whose names are given below can take admission on **14.09.2019 during 08:00 A.M To 12:00 Noon**. The applicants are required to produce their original documents i.e. Mark-sheet (Qualifying Exam.), T.C., Caste Certificate, Weightage Certificate, two (02) Passport size Photographs etc. at the time of admission. **applicants are directed to bring their original mark-sheets of LL.B. I, II and III year or marksheet of Diploma and those who have appeared in Examination 2019 of University of Rajasthan, Jaipur, and don't have their original mark-sheet of LL.B. III year, can bring their online mark-sheet of LL.B. III year or Diploma examination.**

The admission right of the candidates whose names are given in the list is subject to fulfil the eligibility criteria (for General/OBC/EWS/MBC minimum 55% marks in LL.B./ Diploma exam. and for SC/ST/PH minimum 50% marks in LL.B./ Diploma exam.). Candidates who have completed their LL.B. from institutions other than Rajasthan and, are not domicilee of Rajasthan, must have secured minimum 60% marks in their qualifying exam.

Applicants, who fails to produce (i) original documents (ii) Deposit the fee by the date and time noted above and (iii) a study leave certificate from Govt./Semi Govt. Employers (In case of Govt./Semi Govt. Employee),, their admission opportunity shall be forfeited so given **(NO FURTHER CHANCE WILL BE GIVEN TO THE DEFAULTERS IN ANY CONDITION)**.

Note : Fee of Rs. 3,675/- for Male Candidates, Fee of Rs. 1,685/- for Female Candidates and Fee of Rs. 1,685/- for P.H./ Ex-Army of Non-Income Tax payee. Fee can be deposited through Bank Challan in the ICICI Bank situated at University Campus. The candidates are advised to take the bank challan from the Office of the Department of Law and deposit their required fee in the ICICI Bank, and after depositing required fee submit a copy of bank challan in the office of the Department of Law on the same day. Only after this he/she will be allotted Roll Call No. and Section by the office.


