The applicants are required to produce their original documents i.e. Mark-Sheet (Qualifying Exam.), T.C., Caste-Certificate, Weightage Certificate etc. at the time of admission. **Students are directed to bring their original mark-sheets of LL.B. I, II, III Year and those who have appeared in examination 2019 of University of Rajasthan, Jaipur, and have not their original mark-sheet of LL.B. III Year can bring their online mark-sheet of LL.B. III Year.**

The admission right of the candidates whose names are given in the list is subject to fulfil the eligibility criteria (LL.B Professional passed with minimum 48% marks). Candidates, who have completed their LL.B. from institutions other than Rajasthan and are not domicile of Rajasthan, must have secured minimum 60% marks in their qualifying exam.
