The Centre seeks to contribute towards creation of knowledge on Sikh religion, culture and history through research. In the current academic session the Centre has taken up the research project on 'Displacement, Resilience and Recovery: Narratives and Voices of Sikh Migrants in Jaipur City." The project will be completed in two phases. The first

phase would deal with the trauma, travails and tragedy of Sikh refugees who were rehabilitated in Jaipur city after they were uprooted as a result of inter-communal riots that took place following partition of India in 1947and their responses to the catastrophe. In addition to the responses of the migrants, the project would also focus on the administrative challenges that the crisis of refugee rehabilitation threw up before the Government. The responses, initiatives and policy decisions of the Government that was simultaneously confronted with the demanding problems and challenges of a newly independent nation would also be examined. The second part would deal with the contribution of Sikhs to the economy, society and culture of Rajasthan. In the current academic session the first phase of the project would be completed. Center is encouraging its students to engage in research on Sikh history, culture and religion with special reference to Rajasthan.

Following are the future plans of this center:

- Extension Lectures: Three to four extension lectures by eminent scholars on themes related to Sikh society, religion, culture and history would be organized in the current academic session.
- Research Project: The Centre seeks to contribute towards creation of knowledge on Sikh religion, culture and history through research. In the current academic session the Centre would take up research project on 'Displacement, Resilience and

Recovery: Narratives and Voices of Sikh Migrants in Jaipur City." The project will be completed in two phases. The first phase would deal with the trauma, travails and tragedy of Sikh refugees who were rehabilitated in Jaipur city after they were uprooted as a result of inter-communal riots that took place following partition of India in 1947and their responses to the catastrophe. In addition to the responses of the migrants, the project would also focus on the administrative challenges that the crisis of refugee rehabilitation threw up before the Government. The responses, initiatives and policy decisions of the Government that was simultaneously confronted with the demanding problems and challenges of a newly independent nation would also be examined. The second part would deal with the contribution of Sikhs to the economy, society and culture of Rajasthan. In the current academic session the first phase of the project would be completed.

- Collection and Compilation of source material on themes related to Sikh society, religion and culture Collection and compilation of source material on the following from Rajasthan State Archives, Bikaner and other places would be undertaken:
- Sikh Gurudwaras in Rajasthan
- Visits of Sikh Gurus at various centers of Rajasthan such as Pushkar, Naraina etc
- Symposium: A one-day symposium would be organized to share the findings of the project and also provide a platform to the Sikh migrants to share their experiences.
- National Seminar: A two-day National Seminar will be organized in the month of February/March
- Publication: The Centre would publish the proceedings of the seminar and also the report of the research project on "Displacement, Resilience and Recovery; Narratives and Voices of Sikh Migrants in Rajasthan".
- Discussions and book reviews on subjects related to Sikh society, religion and culture would also be organized from time to time.
- Expansion of Library: The library of the Centre needs to be further enriched by books on Sikh history, religion and society and other related themes.
- To resolve funding issues it was suggested by some members that a proposal should be formulated and submitted to the University for making it a center of the University under non-Plan with appropriate budgetary provisions.
- It was suggested that to evolve the Centre as a resource center for Sikh Studies in the University the infrastructural set up of the Centre needs to be improved. It needs to have a well-resourced library, almirahs, computer with printer etc and also more office space to facilitate better functioning and to attract scholars to the Centre.

- It was also suggested that to strengthen the Centre, research scholars in the University's Department of History should be encouraged to take up themes from Sikh religion, history and culture as topics of research.
- It was decided by the Committee that for meeting out budgetary requirements for various heads as mentioned above, requisite proposals be submitted to various funding agencies like UGC, ICSSR, State Government, Rajasthan Sikh Samaj, University (Plan and Project) etc.
