3. Scheme of Examination:

On the basis of these exercise a field work report will be prepared by the candidate under the general guidance of the Head of the Department at least six weeks before the commencement shall examine the field work report in consultation with the teacher in charge and forward the same along with one copy of the report to the University at least four weeks proceeding the examination.

All students would be required to submit a project report of 25 pages on any one research problem under the supervision of faculty members. The assessment wwill be made on the bases of Viva-Voce Examination.
